reconciliation of account is going on. We direct the same to be completed within

15 days. To come up on 18th November, 2019 for the affidavit of the ex-Director.

Mr. Vikas Sharma, appeared for the Statutory Auditor/R-4 is discharged for the

moment. However, he is directed to given full cooperation as and when required

by the ld. Liquidator.
