3.3 The E-Auction would be conducted in the manner specified in the Schedule I, as provided under Regulation 33 of the Liquidation Process Regulations, any other rules, regulations, orders, circulars, directions or notifications or the like, issued pursuant to or under the IBC or the Liquidation Process Regulations, as the case may be, and as per directions, if any, of the NCLT in respect of the liquidation process of the Company and in the manner specified in this E-Auction Process Information Document.

#### **Brief Background:**

Koyenco Autos Private Limited is an unlisted private company incorporated on 20<sup>th</sup>

February, 2003. It is classified as a Private Limited Company located in Kozhikode and registered under ROC- Ernakulam. The registered office of Koyenco Autos Private Limited is at 53 C, Koyenco Housewest Hill, P O Kozhikode-673005, India.

The company is engaged in Sale of motor vehicles [Including wholesale and retail sale of new and used passenger motor vehicles and Lorries, trailers and semi-trailers]. The Corporate Debtor is having properties which were given on rent to the companies engaged in work related to motor vehicles and has currently given one of the properties on lease to Autostarke Private Limited.

### **Insolvency Proceedings:**

An Application under Section 7 of the Insolvency and Bankruptcy Code, 2016 (hereinafter referred to as “Code”) was filed by M/s BMW India Financial Services Private Limited (“Financial Creditor”) against the M/s Koyenco Autos Private Limited (hereinafter to as “Corporate Debtor”) before this Hon’ble Tribunal.

In the sixth meeting of the COC, which convened on 04.05.2022, the RP informed the COC that Form G was published on 25.02.2022 and the last date to submit the Expression of Interest (hereinafter referred to as “EOI”) was 12.03.2022. The RP had received only one EOI from the suspended director of the Corporate Debtor, i.e., Mr. P.P. Ashique. However, he has not submitted any resolution plan within the stipulated time. At that juncture, the COC in its meeting dated 04.05.2022 passed a Resolution by way of a majority of voting to re-publish Form-G. The RP published the second Form G on 10.05.2022 inviting EOI from Prospective Resolution Applicants but again received only one (01) EOI from the suspended director till the last date to submit the EOI i.e., 25.05.2022.

In the seventh COC Meeting which convened on 30.05.2022, the members of the COC decided that the suspended director shall submit the Resolution Plan within the time period of 30 days provided to him, in order to enable the members of the COC to negotiate and reach a decision and that no further extension shall be granted to the suspended director to submit the plan beyond that time.

The Resolution Plan was received by the RP from the Prospective Resolution Applicant/Suspended Director vide email dated 01.07.2022 at 06:27 PM and the RP timely reverted back to them highlight the discrepancies in the Resolution Plan. In the 8th COC meeting held on 06.07.2022, the aforesaid discrepancies were discussed and the members were of the unanimous opinion that since the above-mentioned discrepancies are now cured and also the Earnest Money Deposit has been received by the RP in the bank account, the Resolution Plan as received from the Prospective Resolution Applicant i.e., Mr. P.P. Ashique, Suspended Director, should be considered.

The Resolution Plan was opened in the COC meeting and the RP announced the Financial Bid offered by the PRA to the members of the COC. The RP further apprised the members of the COC that the Resolution Plan was shared with all the members of the COC for their comments and enough time was provided to the PRA, Mr. P.P. Ashique (suspended director) for negotiation with the members of the COC in respect to the financial bid submitted in the Resolution plan. However, in the meeting when Mr. P.P. Ashique was asked to present its revised financial bid, it was understood that no concrete discussion took place between the lenders and the PRA and hence no revision was offered at that time, even though time was sufficient granted from 06.07.2022. The COC took the view that the financial bid offered to them in the Resolution Plan is not acceptable as it is way lower than the Liquidation Value and also due to uncorrected legal and other discrepancies in the resolution plan . Subsequently the COC resolved to grant last opportunity to the PRA to make changes in the Resolution Plan (i.e., Financial Bid and other discrepancies) and submit the final Resolution Plan latest by 26.07.2022 till 05:00 PM and that there will be no further extension of time beyond that. Pursuant to the same, the RP had received a revised Resolution Plan from the PRA on 26.07.2022.

In the revised proposal, the view of the COC members, they were still not comfortable with the revised proposal as there is no substantial change in the revised offer of PRA and other discrepancies in the Resolution Plan were also not corrected. The COC after extensive deliberations and applying their commercial wisdom resolved to reject the revised Resolution Plan submitted by the resolution applicant. Further, due to non-availability other resolution plans and lack of time for further issue of invitation for EOI and since, the previous two invitation for EOI did not yield any positive results, the COC

at its adjourned 9th COC meeting held on July 28, 2022 decided to follow the strict process laid down in the IBC and resolved to seek directions from Hon'ble NCLT to liquidate the Corporate Debtor under Section 33(1) (b).

Subsequently, the RP filed an appropriate application under Section 33 of the Code to initiate the Liquidation Process of the Corporate Debtor on account of the resolution of committee of creditors ("COC") as passed with 100% of the voting on 28.07.2022 in 9th CoC Meeting.

Thereafter, the Liquidation Process of Koyenco Autos Private Limited under Chapter III Section 33 of the Insolvency and Bankruptcy Code 2016 commenced through order of the Hon'ble National Company Law Tribunal, Kochi Bench on 4th November, 2022, and Mr. Vibin Vincent, was appointed as the liquidator of the Corporate Debtor by the order of Hon'ble NCLT, Kochi Bench. **However, the copy of the Liquidation Order was received by the Liquidator on 09<sup>th</sup> November, 2022.**

### **Update on the Liquidation Process: -**

On dated 4<sup>th</sup> November, 2022 the order for Liquidation was passed. The undersigned was appointed as the liquidator by the Order of Hon'ble NCLT, Kochi Bench, Kochi.

The Liquidator made a Public Announcement in Form B, in terms of Regulation 12 of the Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations, 2016 for the commencement of the Liquidation Process, in two (two) widely circulated newspapers in in Delhi (Language Hindi and English) namely, Business Line (All Kerala) and Deepika (All Kerala) on 11<sup>th</sup> November 2022.

In the said Public Announcement, the Liquidator invited claims from the creditors of Koyenco Autos Private Limited in the specified Forms as per the Insolvency and Bankruptcy Board of India (Liquidation Process) Regulations, 2016 and the last date for submission of claims was 9<sup>th</sup> December 2022.

And the same has been uploaded on the website of IBBI and the website of IPE.

## **5. ELIGIBILITY**

A Bidder shall not be eligible to submit a Bid in relation to the sale of the Company if it fails to meet the Legal Criteria and Pre-Bid Qualifications as set out below:

### **5.1 LEGAL CRITERIA:**

*Provided that the person shall be eligible to submit a resolution plan if such person makes payment of all overdue amounts with interest thereon and charges relating to nonperforming asset accounts before submission of resolution plan: 1 Provided further that nothing in this clause shall apply to a resolution applicant where such applicant is a financial entity and is not a related party to the corporate debtor.*

***Explanation I.*** - *For the purposes of this proviso, the expression "related party" shall not include a financial entity, regulated by a financial sector regulator, if it is a financial creditor of the corporate debtor and is a related party of the corporate debtor solely on account of conversion or substitution of debt into equity shares or instruments convertible into equity shares, prior to the insolvency commencement date.*

***Explanation II.***— *For the purposes of this clause, where a resolution applicant has an account, or an account of a corporate debtor under the management or control of such person or of whom such person is a promoter, classified as non-performing asset and such account was acquired pursuant to a prior resolution plan approved under this Code, then, the provisions of this clause shall not apply to such resolution applicant for a period of three years from the date of approval of such resolution plan by the Adjudicating Authority under this Code;*

  - i. *for two years or more under any Act specified under the Twelfth Schedule;*

e) *Is disqualified to act as a director under the Companies Act, 2013.*

g) *Has been a promoter or in the management control of a corporate debtor in which a preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction has taken place and in respect of which an order has been made by the Adjudicating Authority under this Code.*

*Provided that this clause shall not apply if a preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction has taken place prior to the acquisition of the corporate debtor by the resolution applicant pursuant to a resolution plan approved under this Code or pursuant to a scheme or plan approved by a financial sector regulator or a court, and such resolution applicant has not otherwise contributed to the preferential transaction, undervalued transaction, extortionate credit transaction or fraudulent transaction;*

h) *Has executed a guarantee in favor of a creditor in respect of a corporate debtor against which an application for insolvency resolution made by such creditor has been admitted under this Code and such guarantee has been invoked by the creditor and remains unpaid in full or part.*

i) *Is subject to any disability, corresponding to clauses (a) to (h), under any law in a jurisdiction outside India; or*

j) *Has a connected person not eligible under clauses (a) to (i)?*

**Explanation I**– *For the purposes of this clause, the expression “connected person” means:*

i. *Any person who is the promoter or in the management or control of the E-*

- auction process applicant; or*
- ii. *Any person who shall be the promoter or in management or control of the assets of the Company pursuant to sale thereof as part of the liquidation process of the Company; or*

*Provided that nothing in clause (iii) of this Explanation shall apply to a bidder where such bidder is a financial entity and is not a related party of the corporate debtor:*

*Provided further that the expression "related party" shall not include a financial entity regulated by a financial sector regulator, if it is a financial creditor of the corporate debtor and is a related party of the corporate debtor solely on account of conversion or substitution of debt into equity shares or instruments convertible into equity shares, prior to the insolvency commencement date.*

***Explanation II***—*For the purposes of this section, "financial entity" shall mean the following entities which meet such criteria or conditions as the Central Government may, in consultation with the financial sector regulator, notify in this behalf, namely: —*

- a) Minimum **Net Worth of Rs.1 Crores** as per the Financial Statements of the latest Financial Year; The value of the assets for the purpose of arriving at Net Worth would be considered at Cost or the market value whichever is lower.
- b) None of the connected persons including its directors/designated partners/partners have been convicted for any criminal offence under the Indian Criminal Laws.
- c) None of its designated partners/partners are disqualified to act as a 'director' under the Companies Act, 2013.

7.4 Any delay in completion of the Site Visit by the Qualified Bidder, shall not entitle the Qualified Bidder to any extension in the timelines, including the timeline for completion of such Site Visit or submission of the Bid, by or before the last date for submission of the Bid.
