C. INTRODUCTION:

1. The Liquidation Process of the Corporate Debtor has been initiated under the provisions of the IBC and the Liquidation Process Regulations by an order of the Hon'ble NCLT with effect from 11th September, 2024. As per the said order, Mr. Ankit Goel has been appointed as the Liquidator.
2. It is the endeavor of the Liquidator to sell the assets and properties comprising the liquidation estate of the Corporate Debtor in the manner specified under Regulation 32 of the Liquidation Process Regulations, any other rules, regulations, orders, circulars, directions or notifications or the like, issued pursuant to or under the IBC or the Liquidation Process Regulations, as the case may be, and as per directions, if any, of the Hon'ble NCLT in respect of the liquidation process of the Corporate Debtor and in the manner specified in this E-Auction Process Information Document.
3. The E-Auction would be conducted in the manner specified in the Schedule I, as provided under Regulation 33 of the Liquidation Process Regulations, any other rules, regulations, orders, circulars, directions or notifications or the like, issued pursuant to or under the IBC or the Liquidation Process Regulations, as the case may be, and as per directions, if any, of the NCLT in respect of the liquidation process of the Corporate Debtor and in the manner specified in this E-Auction Process Information Document.
4. D. THE COMPANY AND IT'S ASSETS OVERVIEW:

Brief Background:

Sheen India Private Limited is a company incorporated on 15th September, 2005 under the name and style of “Sheen India Private Limited” under the provisions of the Companies Act, 1956 having its registered office at H. No. 211 Near Santhmath Satsang Ashram, Mahroli, Delhi-110068. It is registered at Registrar of Companies, Delhi having an authorized share capital of Rs. 4,00,00,000/- (Rupees Four Crore Only) divided into 40,00,000 equity shares of Rs. 10/- each and paid-up share capital of Rs. 3,54,10,500/- (Rupees Three Crore Fifty-Four Lakh Ten Thousand Five Hundred Only). The CIN of the Company is U00060DL2005PTC140771 and registered email address is rakesh2441@gmail.com. The Corporate Debtor was engaged in the business of manufacturing garments and other allied activities.

Insolvency Proceedings:

The Corporate Debtor was engaged in the business of manufacturing garment and was not performing well in the market. It also took huge loan facilities from Corporation Bank (Now merged with Union Bank of India) and was in severe financial distress. The Corporate Debtor had taken financial assistance in the form of a credit facility of Rs. 1,600 Lakhs from Corporation Bank and loan agreement was executed on 03.09.2017.

That the Corporate Debtor defaulted and failed in fulfilling its payment obligations under the loan agreement read with other security documents. Despite repeated notices and reminders, the Corporate Debtor and Guarantors failed to pay the outstanding amounts which were due and payable to the secured financial creditor. The financial creditor enforced its rights under the SARFAESI Act and sold the immovable properties of the Corporate Debtor.

In light thereof, an application under Section 7 of the Code, was filed by Union Bank of India, vide application no. IB-811/ND/2022, which was admitted by the Hon’ble NCLT, Court-II, New Delhi and the Corporate Debtor was admitted into CIRP on 30.01.2023. Thereafter, pursuant to application bearing IA No. 3422 of 2023 filed by the RP, which was admitted by the Hon’ble NCLT, Court-II, New Delhi and the Corporate Debtor was admitted into liquidation under Section 33 (2) of the Code and appointed the undersigned to act as the Liquidator. Hence, the operations of the Corporate Debtor had ceased to continue.

E. ELIGIBILITY:

An E-Auction Process Applicant shall not be eligible to submit a bid for purchase of assets of the Company if it fails to meet the eligibility criteria as set out in Section 29A of the IBC (as amended from time to time).

LEGAL CRITERIA:

An E-Auction Process Applicant shall not be eligible to submit a bid for purchase of assets of the Company if it fails to meet the eligibility criteria as set out in Section 29A of the IBC (as amended from time to time). A careful reading of Section 29-A of the IBC states that a person shall not be eligible to submit a bid, if such person, or any other person acting jointly or in concert with such person –

- a) Is an undischarged insolvent;
- b) Is a willful defaulter in accordance with the guidelines of the Reserve Bank of India issued under the Banking Regulation Act, 1949;
